



## Pupil Premium Evaluation 2017-18

### **Context**

*The Pupil Premium is allocated in order that support is given to those children identified as being entitled to and in receipt of free school meals. In addition to the funding available for pupils in receipt of free school meals, schools also receive designated funding for children from service families and those who are looked after. In terms of deciding how the funding is spent, the Department for Education acknowledges that it is for schools to make these determinations as they are best placed to assess what additional provision should be made for the individual pupils within their responsibility.*

For the financial year 2017 - 2018, our allocated Pupil Premium funding is **£246,840**

### **Provision Headlines**

- At Gallions Primary School, there are **157 pupils** who are currently receiving pupil premium funding.
- Of the 157 pupils, 104 are currently meeting or exceeding national expectations for their age, (*11 are currently exceeding national expectations*) and 53 pupils are not on track to meet national expectations.
- Of the 157 pupils, 45 pupils currently access in school extra curricula clubs.
- Provision is in place across all year groups with in house interventions for pupil premium children who are working below national expectations. This intervention is geared by attainment, rather than pupil premium status.
- There are 4 pupils with access to learning mentors and the nurture groups. This intervention is geared by need, rather than pupil premium status.
- There are 14 pupils who have made accelerated progress and 11 pupils are not making progress against the national curriculum.
- Out of 157 PP children, 66 have attendance below the school target of 96% = 42%
